PANEL-BASE products are intended for immediate bases under wood and wood-based flooring, indoors. PANEL-BASE panels are used for light floor structures and intended for levelling cement bases before laying floors made of wood-based laminated floor elements. They provide acoustic insulation of impact sounds (muffling layer). The panels may also be used as muffling layer if the impact sound pressure level is PLn-14. PANEL-BASE in rolls is intended for levelling cement bases before laying floors made of wood-based laminated materials. The rolls may be used in rooms with floor heating.
